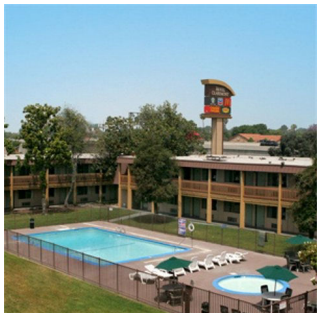


**20th Anniversary Picnic Reunion, Specialty, Multi-breed Shows and Obedience Trials....
